
This primer explores the relationship between corruption and development, and considers how UNDP can integrate anti-corruption with its technical assistance to reduce poverty and promote sustainable development.




The report maps out major corruption risks in the areas of adaptation and REDD+ and makes recommendations to identify actions to minimize these risks.


The Huairou Commission undertook a study of 11 communities across eight countries in partnership with UNDP, to better understand corruption from the perspective of women at the grassroots level.




